SOCIAL MEDIA/WEBSITE PHOTOGRAPH BEST PRACTICES

How many of you have posted a great photograph of an event at the lodge only to get a call from your district, or even the state, Public Relations and Marketing chair to tell you that you needed to take it down? Sometimes this can be because the image shows the Elks in an unflattering light, or show questionable behavior, or even be embarrassing for individuals in the photograph. Photographs posted to the lodge social media or web pages can also land the lodge in legal trouble if the photograph adversely affects someone in the picture (e.g., a member applying for job has their prospective employer find pictures of them playing a drinking game at the lodge). To avoid these issues here are some "best practices" to keep in mind when posting photographs:

- <u>Do not post</u> or share pictures without consent, especially of minors. Always ask before posting and for minors have a signed release from a parent or guardian to use their image.
- 2. <u>Do not post</u> or share full names or tag individuals in photographs that are publicly posted. You can ask for consent to post the name of an adult, but the names of minors should never be used in full and only first names with the parents' consent.
- 3. <u>Do not post</u> or share pictures of the bar, drinking or other "vice" activities such as gambling or smoking. These activities may be fun and show good times at your lodge, but they also contribute to a negative perception of the Elks as a bar and not a charitable organization.
- 4. <u>Do not post</u> or share a picture that someone would be ashamed for their family, friends, or employer to see. Keep in mind that nothing is private on social media. Assume if you share something embarrassing that someone will see it who probably shouldn't.
- 5. <u>Do not post</u> or share pictures of hospitality rooms or hosted bars on lodge pages.
- 6. <u>Do not post</u> or share pictures that show activity in violation of federal, state, or local laws and/or ordinances. For example, if local ordinances dictate minors cannot be in certain areas DO NOT post a picture of a minor having their birthday party in that area.

REMEMBER TO INITIATE CANDIDATES

Nationwide the Elks were down about 40,000 members last year due to the pandemic and its impact. However, in just the first three months of this year the Elks have already initiated about 11,000 new members and have over 12,000 candidates awaiting initiation. If all of these candidates are initiated that means the Elks will have gained back more than half of last year's losses in just the first three months of this year. So, remember to get those candidates initiated and let's get back to growing Elkdom with a gain in membership!

GRAND LODGE NATIONAL CONVENTION

There isn't much that can get some of us up at 2 am but heading to the Grand Lodge National Convention is one of those times we haul ourselves out of bed and head for the airport to catch our flights out. This year was no different with many of the Oregon State Elks Association members flying out early in the morning on July 3rd headed for Tampa where we joined over 6,000 of our fellow Elks to celebrate our order and conduct its business following the cancellation of the Baltimore convention last year.



This year we hit the ground running with sessions starting early on Sunday July 4th covering a range of topics from public relations to the Drug Awareness Program. Members also gathered to help prepare for the celebration of the election of T. Keith Mills as Grand Exalted Ruler for 2021-22 on Monday. The festivities officially kicked off with the opening ceremonies Sunday evening during which Oregon's flag proudly



made its entrance into the convention waived by OSEA President Rick Shipley and Past State President Kim Duty. Members received reports on the Elks efforts to restore displays and improve the experience at the Pearl Harbor National Historic Site, the Elks Drug Awareness

Program, the Hoop Shoot, and our national Most Valuable Student scholarship winners. The ceremonies ended with the keynote address by Grand Exalted Ruler Paul Ryan after which the celebrations began with the Party Crashers Band and ended with a spectacular fireworks show over the bay to celebrate the 4th of July.



Monday's session started promptly at 8am and among the business of the day was the nomination and election of the Grand Lodge Officers for 2021-2022 including a man many of us know personally, T Keith Mills from Caldwell

Idaho lodge as Grand Exalted Ruler. Members from Oregon and Washington helped with the celebration of the election of our new GER by helping toss trinkets to the crowd of delegates.

In addition to the election and celebration we got to hear from Grand Exalted Ruler Elect Mills as he accepted his election. In addition, delegates heard more reports from the Grand Lodge committees and had the chance to attend more sessions to learn more about a range of topics such as the Financial Reporting System and more. By the end of Monday, we started to understand that we may be in for a memorable trip to Tampa in more ways than one.



Tuesday saw an eventful day that started off with our group photograph at 7 am before the day's sessions. But as we were going through the day's business of hearing committee reports, the GER Elect's program remarks, and the legislative results, Hurricane Elsa was making its way towards Tampa. Many of the afternoon breakout sessions ended up shortened or cancelled as we all prepared to



shelter in place to ride out our first hurricane. Thankfully the storm changed direction and kept us from getting the worst of it, and many delegates commented

that we have had greater winds and rain in Portland. But, according to the Florida State Elks Association president, we can officially mark off our bucket lists going through a hurricane. Due to the possibility of a hurricane, it was decided to reschedule our planned dinner cruise to Wednesday night. Those familiar with the plot of Gilligan's Island appreciated the re-scheduling.

One advantage of a potential hurricane is that the last day of sessions was delayed from 8 am to 10 am giving delegates a chance to sleep in or to grab a good



breakfast before the last day of the convention. The day's sessions consisted of the annual Elks Memorial Service which pays tribute to those members we lost this past year as well as to install the incoming Grand Lodge Officers for the new year. Following the session, members had a chance to explore Tampa before Oregon and Idaho members set sail on our delayed dinner cruise around the bay. The cruise



included a fantastic dinner as well as dancing on the top deck as we sailed back into Tampa. But our historic trip to Tampa was not quite over yet. Later that night the Tampa Bay Lighting, defending Stanley

Cup champions, won their second straight Stanley Cup Championship. To say the city came alive in celebration would be an understatement.



All in all, the Tampa trip was a great chance to meet Elks from across the nation. Members were able to meet and connect with Elks they have talked with and met online all for the first itme in person. Members also explored Tampa from historic restaurants like Columbia, to the eclectic offerings of the historic Ybor City district. Our time in Tampa included the celebration of a new Grand Exalted Ruler from our own Area 8, celebrating the 4th of July, a hurricane, and a Stanley Cup win. But through it all, the common thread was that it was great to be an Elk, it was great to be an Elk in Tampa, and it was great to be back at our Grand Lodge National Convention. We look forward to the next convention in 2022 in Atlanta, Georgia.
