

Membership resources: reducing delinquency

In the first quarter of the 2023-2024 fraternal year, we have added over 1,000 new members to our rolls here in Oregon. This is an outstanding pace of bringing in new members! We also have over 500 candidates waiting for initiation into our order. These numbers should give us over 1,600 new members in Oregon. Unfortunately, even if we initiated each of those candidates, we would still have a net loss over 1,800 members. This is because we have over a 13% delinquency rate (over 3,200 delinquent members) as a state. When looking at lodges we have some lodges with over a 20% delinquency rate. Ideally, we should be aiming to have our delinquency rate as close to 5% as possible. If we currently had a 5% delinquency rate we would have a projected gain of nearly 200 members and every reinstatement and new initiate would just grow that number even more.

So how can you help bring down your delinquency rate? It is simple, engage your delinquent members! If you are in the Grand Lodge Dues Billing program, your delinquent members are getting billing statements and the OSEA has been reaching out to delinquent members via email. But one of the best ways to retain members is the personal phone call or even a letter from the lodge. And the best part is you don't have to figure out what to say to these members. The Grand Lodge Membership and Marketing Committee has sample letters and phone scripts you can use to contact your delinquent members. These resources can be located at <u>https://virtualmanuals.elks.org/membership-guide/</u> as well as other membership resources.

Now lets be honest, not every delinquent member is going to renew for a variety of reasons. It can still be valuable to reach out to those members to learn from them the reasons they may not be renewing. It will provide insight that you can use to help prevent further membership loss. For example if you get a lot of feedback that members are dropping because they don't like the events your lodge is having you might want to consider some different events. You may also learn that a delinquent member is experiencing some kind of financial hardship or health challenge. Keep in mind our order is dedicated to brotherly love, and in appropriate circumstances your lodge standing relief committee can consider such cases on a case by case basis. Especially when considering long time or even charter members. And keep in mind, it does not just have to be the lodge Secretary or lodge officers who contact delinquent members. Check with your lodge Secretary or Exalted Ruler to find out how you can help.

A few things to keep in mind when contact delinquent members:

- 1. Have a pen and paper handy to take notes if needed.
- Have the lodge credit card terminal ready in case someone wants to pay their dues over the phone by credit card. Also make sure to have the lodge mailing address available to give out as well.
- 3. Unless calling members you personally know it is best to call from the lodge phone line.
- 4. Introduce yourself, state you are calling from the lodge, and why you are calling.
- 5. If someone doesn't want to talk about it, don't push. You don't want to make them angry or push them away.
- 6. Always thank them for taking the time to speak with you.

And remember, if you are not sure what to say you can always check out the membership guide posted to the Virtual Manuals site. Together we can help reach Oregon's 2023-24 membership goal of a net gain of 1,000+ new members! This past year we were 5th in the nation for membership and this year we want to do even better and show the rest of Elkdom the great work we are doing in the Pacific Northwest, in Area 8, and right here in Oregon to show communities that We Are the ELKS!!!

Introduction to the OSEA Laws Committee The purpose of the OSEA Laws Committee is to assist the State Association in establishing a uniform method and procedure for reviewing, proposing, and submitting changes to its Constitution and Bylaws, and to submit those proposed amendments in a timely manner.	endorse it, and inform the Laws Committee not less than forty- five (45) days prior to the Summer Convention; f) The State Secretary will distribute the proposal(s) to all State Lodges not less than thirty (30) days prior to the Summer Convention; and g) Amendments may only be adopted by a majority of voting delegates at the Summer Convention.		
The scope of the Laws Committee includes reviewing all proposals for amendments to the OSEA Constitution and	At the request of the President, the Laws Committee will prepare and present upon the floor of the State Convention resolutions on behalf of the State Association.		
Bylaws that have been submitted by a Lodge, State Officers, or a State Committee. The Committee Chairman is appointed by the Association President each year, along with a committee representative from each District upon recommendation by each District Vice President. The responsibilities include: a) coordinating with the State President and State Secretary and reporting on all proposed amendments with timelines needing to be met for approval; b) forwarding all approved Bylaw amendments to the State Secretary so they may be prepared for membership voting at the Summer Convention; and c) preparing a written report to be presented at the Summer Convention.	The Executive Committee has approved and authorized amendments to be brought before delegates at the Fall Seminar so that the OSEA does not have to wait an entire year between voting on proposed amendments. Currently there is likely to be at least one proposed amendment that may be used as a real-time test of how logistically new amendments could be voted on mid-year. Also, as a member in good standing, if anyone has a proposal they would like to have considered, then it should be submitted through one of the three bodies mentioned supra: Lodge, State Officers, or a State Committee.
