Pre-registration for Convention opens in April

Online pre-registration for the Grand Lodge Session in Minneapolis opens April 1 and will be available at elks.org/ convention/prereg.cfm through June 28.

Registration will be open on Friday, June 30, from noon until 4:00 p.m. in the Minneapolis Convention Center. Be advised, Exhibitors and Vendors will not be open at this time. Normal registration and Vendor/Exhibitor hours will begin Saturday, July 1, at 8:00 am.

The online pre-registration fee is \$50 for all Members. The on-site registration fee will be \$60. A current credit card for PayPal will be needed. There is no fee for a non-Elk spouse or guest.

A registration badge will be required to enter the exhibit hall and all business sessions.

Another area of critical focus at the onset of a new Elks year is membership. Work with your appointed Membership/ Membership Retention Chair as a team. All of your Lodge Members are a part of your membership committee. It is important to reach out to delinquent Members in order to bring them back into your Lodge. It may only take one phone call. There is a chance that by speaking with the delinquent Member, you may get them to renew their dues and become an active Member again.

Your Lodge Secretary plays a very important role for Members who were dropped for nonpayment of dues. I encourage you to review Statute 14.180. This Statute is very clear that your Lodge Secretary shall advise the unaffiliated of his/her rights to reaffiliate within 60 days.

Make +1 in membership a priority during your term. I know our Grand Lodge Membership Marketing Manager Rick Gathen would be very proud to say your Lodge achieved a +1 in membership. With the leadership team you have put together, I know how hard you will be working on "Promoting Elkdom With Enthusiasm."

April also is the month when families get together for Passover and Easter. Helen and I want to wish you and your families a wonderful holiday celebration.

In closing, thank you for your continued leadership this year by working hard within your communities to show that "Elks Care — Elks Share."

Good deeds become official after documentation

There is an old adage that I think about once in a while, the punch line of which is, "The job ain't done 'til the paperwork's done." I won't describe the picture that accompanies this saying, but the punch line surely summarizes the problems we face with regards to our survey of Volunteer, Youth, Charitable and Community Service Programs.

If some find this topic to be repetitive with regards to Grand Lodge Government Relations Committee newsletter articles, you are correct. That's because of the extreme importance of an accurate, Lodge-by-Lodge, state-by-state summary of what we do and what we contribute in the name of charity. The significance of our survey cannot, in any way, be overly emphasized because of its usefulness for the survival of our Benevolent and Protective Order of Elks.

Previously, our committee has warned that some governmental individuals and agencies believe our fraternal organization is simply a source of wealth, waiting to be tapped for the benefit of governmental projects and programs. Combating that perception was a purpose for which our Grand Lodge Government Relations Committee was originally formed. Committee members on the national, state, district, and local level continually work to challenge the misconception that we are just another business that should be subject to full taxation.

Over the past many years, Government Relations Committee members at all levels have strived diligently to defend our charitable organization. We have improved the overall procedure of keeping track of our charitable reports, including donations, hours of service, and mileage in order to make it easier to track and forward all such information to Grand Lodge. We have also worked to spread the burden of inputting statistics to include other Members of the Lodge, so as to lessen the work of our Lodge Secretaries, who have borne the brunt of this task for many years.

These endeavors are working, but progress has been slow. It is suggested that Lodges reassess their present practices so the clerical system associated with our survey becomes easier to manage and maintain, thereby making the procedure more accurate and time efficient. Doing so will involve some changes, and we all know most individuals and organizations

are afraid of change—yet change is necessary to insure our future.

Continuing to improve our reporting system must be accomplished, in addition to increasing our influence within our communities through a consistent effort that builds relationships with local, county, and state elected officials. Doing so will validate our importance within our communities and improve our reputation.

New orientation video now online

We have worked to restructure and shorten the Orientation video, making the messaging more concise and well-organized. It's been nine years since the orientation video was changed.

The BPOE continues to strive to attract a younger and more diverse membership. The restructured orientation video better reflects those goals along with our progress.

Graphics and social media

A few weeks ago, you received an email from Area 8 Grand Lodge Membership and Marketing Chair Steve Meier regarding the use of non-Grand Lodge officially branded graphics on social media. From his message, you should only be using graphics from approved Grand Lodge or OSEA approved pages. These pages are:

Several of you have responded that you do not know how to tell what is an approved graphic and what is not. There are two very easy ways to tell that a graphic is not from an approved source: First, if the logo on the graphic IS NOT the official Elks USA Logo used by the Benevolent and Protective Order of Elks nor the official logo of the Oregon State Elks Association. Further the logo has never been a logo of the organization nor is one of its trademarks. Second, officially released graphics from Grand Lodge sources or the OSEA do NOT include any artist attribution on them. They are only branded with either the official logo of the Elks or the Oregon State Elks Association.

Below, is an image released from Grand Lodge links that shows what official Grand Lodge Images look like. Note the appropriate Grand Lodge Logo and lack of artist attribution. These links also include graphics available for a variety of holidays, lodge events, rituals, and more. Further, Grand Lodge is also actively developing more. If you have suggestions for graphics, please send them to me and I can forward onto the appropriate individuals for consideration. In the meantime, please refrain from sharing items on your lodge social media and websites that are not aligned with Grand Lodge branding and messaging. It is important that the Elks brand is identifiable, and use of unapproved images not using proper logos or messaging does not help that effort.



Betty Hise for Cancer Research

Thank you to Salem Lodge # 336 for the March 4th, 2023 scheduled 'Comedians Against Cancer'. This fundraiser for Betty Hise for Cancer Research, Inc. features the comedy of Adam Pasi, Drew Wilson-McGrath and Dianna Potter. We look forward to reporting fun around contributing to Cancer Research!

Betty Hise Directors are planning for our luncheon at Summer Convention in Seaside on Friday April 28. Checkin 11:30a for the "Birthday Party" theme as we celebrate 35 years of fundraising for Cancer Research! Invite is included in the Registration information recently sent to all lodges. Our Speaker this year is Tammie Eslinger, Senior Manager of Clinical Research at St. Lukes Cancer Institute (SLCI) in Idaho. Our 2022 end of the year funds have been redirected from previously reported ADEPT program to a colon cancer research study they are currently involved in. SLCI is in collaboration with Dana Farber Harvard Cancer Care Alliance examining why colorectal cancers are increasing at an alarming rate in people under the age of 50. This is a worldwide issue, and Idaho has one of the highest increases. They are studying samples as well as asking extensive questions about lifestyle and diet in attempt to identify something similar that is causing colon cancer. Specimens are saved for use in identifying or developing drugs to give these patients a better chance of survival. To compare the differences between people who get cancer and those who don't, they are gathering the same information from healthy volunteers. We look forward to hearing more about this program from Tammie Eslinger who has 24 years experience in Cancer Research.
