OSEA President's message Hello Elks!



One of the things about serving as OSEA President is that you get to raise funds for something you care a lot about. While Cody and I care about EYES and Meadowood and Veterans, we care a lot more about the Lodges of Oregon. We believe that if a Local Lodge is kept open even one more year, the charity

and work they do is worth more than any amount we could ever raise for any one charity in a year. Because of this, I am excited to announce the start of a new OSEA Program called the Lodge Improvement Fund, or LIFe for short.

In a nutshell, the OSEA is going to give two lodges \$1000 each to make physical improvements to their property. To apply, the Lodge must submit their All-American Lodge form to the District Deputy (which is now required anyway) along with a "before" picture of what you want to improve and a one page summary outlining your project timeline, budget and goals. The DDs, DLs and our sponsor will forward pass one or two applications per District to the State Officers who will choose two winners. The winning Lodges will receive a \$1000 check at Summer Convention. Go home, complete the project by Oct 1, send an "after" picture and receipt copies for \$1000 to the State Secretary by October 10 and you are done. If you spend less, just send the leftover money back. We will give it out next year.

The initial funds will be those monies collected by Cody and I in our travels this year. The OSEA has been asking Lodges to update, now we are helping out and giving it back. While there are plans to expand the LIFe fund to give even more back to our Lodges, these grants represent the spirit and intent of the LIFe fund moving forward. We all know a little

project that members can see can spark the next and then can snowball into growth and success. I hope that happens every time for those Lodges who apply, win and utilize these monies for years to come.

Remembering 9/11

The following remarks were delivered by OSEA President Nick Bettencourt at the Albany 9/11 Remembrance marking the 22nd anniversary of the attacks.



Good Morning,

My name is Nick Bettencourt and I have the honor of serving as the State President of the Oregon State Elks Association and

to represent all Oregon Elks at today's ceremony.

September 11th, 2001, was the day of infamy for the 21st century. It was a day that will live in the annals of courage and patriotism. Today we pay tribute to those who were lost and those who survived. The heroes at ground zero who in life and death, wear an indelible badge of honor. We celebrate not only them, but all of our fellow Americans, for the intended victims of this attack were not just the World Trade Center, the Pentagon, or the people on flight 93. The targets were not just the symbols of America, but the very spirit of America, and the intended victims were all 330 million of us. The attacks on September 11th were intended to break our spirit, but instead, we emerged stronger and more unified.

Elks Preschool Vision Screening Program marks 20 years!

Since 2003, the program has provided free vision checks for more than 65,000 toddlers, about 15% of which have needed glasses. The program's \$350,000 annual budget is fully supported by the Oregon State Elks Association.

"A screening that lasts just a few seconds can save a child's sight," explained program director Joannah Vaughan, M.B.A., who is also an assistant professor of ophthalmology in the OHSU School of Medicine.

About 80% of early learning is done visually, and children can fall behind in school without clear vision. Vaughan has heard directly from kids – some of whom have danced and admired posters on the wall that they could see clearly for the first time after they received glasses – that correcting vision issues can make a real difference. Teachers have also told her that behavioral issues in some children decline or disappear after they get glasses.

When caught early enough, treatments like patches, special drops and glasses can help affected eyes catch up. But if not treated by age 7, children can be left with permanent vision loss. The ideal timeframe to treat amblyopia is between the ages of three and five, when children attend preschool. In its 20 years, the Elks Preschool Vision Screening Program has correctly identified at least 1,000 kids with amblyopia.

In addition to amblyopia, the program also screens for farsightedness, near-sightedness and astigmatism, which causes vision to be blurry or distorted. When a potential vision issue is flagged, the program sends a letter to a child's guardians that recommends they make an appointment with an eye doctor for further evaluation and treatment if needed. To encourage timely follow-up, the program also calls guardians, provides a list of trusted providers who are accepting pediatric patients, and offers bilingual support to make an appointment if needed. Oregon Health Plan, the state's Medicaid and children's health insurance plan, covers pediatric eye exams and prescription glasses.

With guardian permission, the program team also follows the children they screen for years afterward to evaluate the accuracy of their screening practices as well as to track pediatric vision trends. The team has published 19 peerreviewed papers, presented at numerous medical and health conferences, and advises other organizations on vision screening best practices.

Kosmo Quiroz Acero was three years old when the Elks Preschool Vision Screening Program visited his Head Start classroom in 2011. Vision screeners found a potential problem and referred him to the OHSU Casey Eye Institute, where a pediatric ophthalmologist diagnosed him with amblyopia in both eyes. The physician showed his mother, Delfina Acero Chuma, how to help her son place an eye patch over one eye at a time, which sharpens vision in the other eye by forcing it to develop further. Routine use of prescription eye drops and prescription eye glasses also helped improve his vision.

Now 15, Kosmo can see well with the help of eye glasses. He's currently a junior at Cleveland High School in Southeast Portland and is considering becoming an engineer.

Essay Contest participants will consider Bill of Rights

The topic for this year's Americanism Essay Contest is "What the Bill of Rights Means to Me." This is the second year to have the new divisions and monetary prizes. The contest has separate divisions for fifth, sixth, seventh, and eighth grade students. For each division, first place wins \$1,000, second place earns \$500, and third place gets \$250. There are some very important dates to remember. If you miss your deadline, your essay will be ineligible to win. Keep in mind that all initial essays should go to the Local Lodge first for judging. It is important to communicate this information to your schools and teachers. Keep in mind that you should send your essay to the Elks Lodge nearest your home, and only to one Lodge! Each level of judging will send the top three in each division to be judged on the next level.

Deadlines

- Student/teacher sends essays to Local Lodge: No later than December 15, 2023.
- Local Lodge sends to District Chair: No later than January 31, 2024.
- District Chairman sends to State Chair: No later than February 28, 2024.
- State Chair sends to Contest Administrator: No later than March 31, 2024.

Rules

- 1. No more than 300 words. Essays must be typed or legibly printed in ink (by the entrant).
- 2. Must be submitted to the Lodge nearest their address.
- 3. The participant must be identified by name, grade, school attending, and the sponsoring Elks Lodge on the essay itself.
- 4. The cover page provided on our website must be attached to the essay. This cover sheet will follow the essays through every level of judging.

Judging and scoring

- 1. Originality. Avoid the use of clichés and worn-out words and phrases. 30 points.
- 2. Development of the theme. Stay focused on ideas and thoughts. Don't ramble. 40 points.
- 3. Mechanics and neatness. Use proper spelling, grammar, and punctuation. 30 points.

Publicize your contest via social media, newsletters, and e-mail blasts, as well as through local newspapers and radio. Prizes at the local level are also a good idea for increasing participation. National winners of first, second, and third place in each division will be announced in our spring newsletter.
