OSEA President's message




Welcome to Fall.

Fall also brings the reopening of schools in your communities and tremendous occasions for our Lodges to encourage our youth. Supporting local football, soccer, lacrosse and other sports programs and youth-related activities are wonderful ways to show your Lodge's support and personal community spirit! Look into and apply for the many Elks National Foundation grants. These grants are available to assist financially in your community partnerships with our youth, veterans, and community members. Seek out your school guidance counselors and provide them with the needed student applications to apply for grants that can aid students with much-needed financial support. These scholarship grants include the \$4,000 Legacy Awards, \$5,000 Emergency Educational Grants, Most Valuable Student Scholarship for up to \$50,000, or a Gunther & Lee Weigel Medical School Scholarship. This was quickly followed by an announcement that the plane crash was not an accident, but a deliberate attack on the building. Reports indicated that the attackers first flew intentionally into the North Tower, followed only minutes later by another intentional strike into the South Tower. Shortly after, there were broadcasts of a third plane that flew into the Pentagon building and a fourth plane that crashed in a Pennsylvania field. Many innocent lives were lost that day.

The Elks remember September 11 each year and honor all those who lost their lives during these horrific attacks, including the first responders and community members who sought to help the crash victims. In this regard, the Elks have developed a Patriotism Week Proclamation that I encourage all Lodges across our great country to embrace. Have your local government officials place it on their agenda to recognize our freedom and to honor our nation.

OSEA Marketing Update

As mentioned in last months newsletter, July was the first month of our 3-month radio advertising campaign and we have been hearing from people around the state who have heard our ad. In addition, we also received a report from the Oregon Association of Broadcasters with data on our first month. This report showed that our \$12,000 investment is clearly being returned. Our add was played on over 100 stations a total of 5,108 times in the month of July. This airtime has a value of almost \$81,000.

And as you can see from the map below our ad has been heard in every corner of the state (note: the map shows the cities of the stations primary transmitter the ads are playing in Ontario, Klamath Falls, and other areas in the south eastern corner of the state). The average number of plays for each station is 50 times for the month of July.


In addition, we have been tracking our website and social media traffic both before and during this radio campaign. We

have seen a significant increase in traffic on both our website and our Facebook page.

Coming soon we will be releasing a guide for local lodges to use to reach out to these stations who have been playing our ad to make connections and work to get your local lodge and events featured on the radio. This will be a helpful resource to you in helping to get out the message of who the Elks are and what we do in our communities.

We also still have the customizable graphics available that you can request for you lodge to use in newsletters or on social media.

The OSEA is providing these tools to you in order to help promote your lodge, engage your members, and grow membership. But like any tool, these are only useful if you utilize them. My Elks Mobile App Special offer

For the past five (5) months a small group of dedicated Elks have worked diligently on developing a mobile app for the Lodges in Area 8 with the final goal of presenting it to all Lodges in the Order. The "My Elks" app is now available and ready for use. The core team has demonstrated in 4 States and at Grand Lodge in Atlanta.

The app developer, Giant Killer, has been working with us on standardizing a reduced monthly fee. The current fee for all Giant Killer users is \$150.00 a month. Through the efforts of the core team, we have been able to get a reduction in price from \$150.00 a month to \$95.00 a month per Lodge.

We feel strongly that this mobile app is the way of the future for increasing Lodge participation and thus a gain in membership. We would like to see every Lodge in Oregon using the app. and to that end we have volunteers willing to provide support in setting up the app in each Lodge.

In addition, the core group has come to the OSEA requesting financial support in achieving the goal of all Oregon Lodges using the app. After consultation with the Public Relations and Marketing Committee and Area-8 P.R. and Membership Marketing Committeeman Steve Meier, the OSEA is offering the following.

For every Oregon Lodge that commits to a one-year subscription on the "My Elks" app the OSEA will reimburse \$500 of the cost. This will make the total cost to a lodge for 1 year \$640 which is less than \$55 a month. For a Lodge to qualify for this discount it must submit proof of payment to Giant Killer of \$1,140 for a 1-year subscription to the My Elks mobile app to the State Office by December 1, 2022. This will give every Lodge a year to work on selling advertising for their app as well using its features to increase participation and engagement. In addition, we will be discussing the app at the upcoming OSEA Fall Seminar in Baker City.

Drug Awareness & Americanism Contests

School has started and it is time for the Drug Awareness contests. Available are poster, essay and video contests. Oregon has five Districts and each Lodge has a Drug Awareness representative. Either a DAP chair or the Exalted Ruler will have information concerning rules for each contest and the ages for participation. Contests start September 15th, 2022 and projects must be turned into The Lodges by December 10th.


The Lodges will send all contest submissions to their respective District Drug Awareness Chairs by January 10th 2023. The District will submit the district first and second place winners to the OSEA Chair by February 2, 2023. This year's theme is "ONE PILL CAN KILL" the District chairs are listed in the State Directory. Parental hold harmless forms must be submitted with entries. Forms are on OSEA site under contests.

The Grand Lodge Fraternal Committee has selected the theme, "What is your American Dream?" for the 2022-2023 Grand Lodge Americanism Essay Contest. The contest starts with the Local Lodges, progresses through District and State levels, and ends with the naming of our National Winners at the Grand Lodge Session in Minneapolis, MN in July 2023. This contest gives students in four separate grade levels, grades 5-8, the opportunity to thoughtfully, evaluate and express their views on the selected annual theme.

Nationally, first-place, second-place and third-place authors in each division will receive monetary awards of \$1,000, \$500, and \$250 respectfully. Many Lodges, Districts and State Associations also provide various forms of recognition to their respective winners, and the Fraternal Committee appreciates and encourages their extraordinary efforts in support of the contest.

Contest materials including the "annual contest theme" are published on-line on May 1. Lodges are encouraged to communicate with school officials in a timely fashion to facilitate annual curriculum planning. We ask that you please be patient with us as we work on these updates to the OSEA website. Our goal is to be able to launch the completed revamp in time for the 2023 OSEA Summer Convention in Seaside.

Drug Awareness Program - Fentanyl

WASHINGTON – The Drug Enforcement Administration is advising the public of an alarming emerging trend of colorful fentanyl available across the United States. In August 2022, DEA and our law enforcement partners seized brightlycolored fentanyl and fentanyl pills in 18 states. Dubbed "rainbow fentanyl" in the media, this trend appears to be a new method used by drug cartels to sell highly addictive and potentially deadly fentanyl made to look like candy to children and young people.

"Rainbow fentanyl—fentanyl pills and powder that come in a variety of bright colors, shapes, and sizes—is a deliberate effort by drug traffickers to drive addiction amongst kids and young adults," said DEAAdministrator Anne Milgram. "The men and women of the DEA are relentlessly working to stop the trafficking of rainbow fentanyl and defeat the Mexican drug cartels that are responsible for the vast majority of the fentanyl that is being trafficked in the United States."

Brightly-colored fentanyl is being seized in multiple forms, including pills, powder, and blocks that resembles sidewalk chalk. Despite claims that certain colors may be more potent than others, there is no indication through DEA's laboratory testing that this is the case. Every color, shape, and size of fentanyl should be considered extremely dangerous.

Fentanyl is a synthetic opioid that is 50 times more potent than heroin and 100 times more potent than morphine. Just two milligrams of fentanyl, which is equal to 10-15 grains of table salt, is considered a lethal dose. Without laboratory testing, there is no way to know how much fentanyl is concentrated in a pill or powder.

Fentanyl remains the deadliest drug threat facing this country. According to the CDC, 107,622 Americans died of drug overdoses in 2021, with 66 percent of those deaths related to synthetic opioids like fentanyl. Drug poisonings are the leading killer of Americans between the ages of 18 and 45. Fentanyl available in the United States is primarily supplied by two criminal drug networks, the Sinaloa Cartel and the Jalisco New Generation Cartel (CJNG).

In September 2021, DEA launched the One Pill Can Kill Public Awareness Campaign to educate Americans about the dangers of fake pills. Additional resources for parents and the community can be found on DEA's Fentanyl Awareness page. If you encounter fentanyl in any form, do not handle it and call 911 immediately.
